### LIST AND INDEX OF REPORTS AND TRANSACTIONS, 1854-1957

The publications of the Oxfordshire Archaeological Society are a somewhat confusing series, inconsistently named as *Reports* or *Transactions*, often unnumbered, and varying between slim pamphlets and full volumes. Happily this bibliographic fog was cleared in 1949 when the 87<sup>th</sup> Report included a full listing of the contents of previous publications (perhaps by Howard Colvin), that forms the basis of the present list. A separate index was printed after 1957. Unfortunately, the revived Society was not to last for long, and while the next five *Reports* were published in *Oxoniensia*, the 92<sup>nd</sup> in 1957 was the last. The Society's minute books continue to 1971 until it amalgamated with the Oxford (subsequently Oxfordshire) Architectural and Historical Society in 1971-2.
